Full-time, Exempt Remote Position but must reside in California. Periodic travel to Sacramento is required (costs reimbursed). \$110,000 - \$125,000 depending on qualifications.

We are excited to announce this new opportunity to join the Child and Family Policy Institute of California (CFPIC) Team and help lead our organization's efforts in support of county teams who are strengthening and leveraging System of Care partnerships to implement CalAIM and other behavioral health initiatives, advancing innovative models of care, and optimizing resources to meet the needs of children, youth, families, and Tribes. In partnership with the CFPIC Senior Associate Director, the Project Director will provide strategic planning support, direction, oversight, and coordination of the CBSI project and associated staff (mostly contractors).

Typical Duties:

- Participate in the development of the CBSI overall project blueprint
- Support a cross-system, statewide strategic planning process
- Monitor project progress, plan deliverables, and budget
- Support peer network building and relationships between county Human Services Agencies and their public and private implementation partners
- Ensure timely and responsive communication between project staff/contractors and counties
- Provide facilitation and coordination of workgroups, teams, and cohorts of counties
- Develop strategic tools, documents, presentations, etc. to support training and project implementation

- Coordinate support to individual agencies, county teams, and cohorts of teams
- Support the evaluation of the project
- Completing essential job duties that are not listed above but are relative to this position classification.

Minimum Qualifications:

- Demonstrated knowledge of public Health and Human Services Systems, including Behavioral Health Services and Medi-Cal Managed Care programs in California
- Demonstrated knowledge of CalAIM, and familiarity with ECM, CS, and Transitional Support Services
- Experience with AB2083/System of Care vision and recent participation on a county ILT
- Project management, strategic planning, and budgeting
- Ability to build networks, to form and sustain cross-discipline relationships
- Excellent oral and written communication skills

Experience:

Three years of increasingly responsible administrative or managerial experience related to planning, organizing and directing human services and/or behavioral health programs.
