## Introduction

The Youth Engagement Project (YEP) is pleased to share the third edition of our quarterly newsletter, highlighting the meaningful work being done by both YEP counties and Youth Ambassadors, as well as updates on the program as a whole.

YEP, a flagship program for the Child and Family Policy Institute of California (CFPIC), and with funding from the California Department of Social Services (CDSS), encourages youth engagement by lifting up youth voices to improve child welfare systems in local jurisdictions and at the state level.

For the third quarter of the year, the YEP program has been extremely busy as we continue to grow and being asked to be present in more spaces. Youth Ambassadors have become more comfortable in their roles with their counties and are working hard on their various focus areas.

In addition, the program recently conducted a program evaluation and the findings were very positive. Overall, nearly 90% of the Ambassadors felt that they were making an impact on the child welfare system. They also shared that YEP creates self-efficacy, and gives ambassadors hope for the future, facilitates their own healing from past traumatic events, and provides opportunities to practice professional skills, widen their networks and advocate for change.

In other exciting news, the program has added San Francisco and Marin as new county partners, and are in the process of identifying youth ambassadors to support their vision and efforts around youth engagement. Several other counties are also interested in a partnership, and we look forward to growing to over 20 participating counties by next fiscal year!

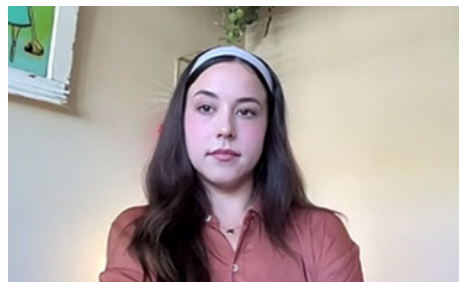
# *Youth Ambassador Updates*

This quarter has proven to be very busy for the youth ambassadors with numerous requests for youth voice opportunities, with some examples listed below:

***Statewide Prevention Convening-*** Sophia Jeffe and Nancy Perez both provide opening remarks at the Statewide Prevention Convening in March. Both Youth Ambassadors shared a bit about themselves and why it is so important to use youth voice to do prevention work. Their commentary was extremely well received.

***California Human Services Committee-***Lauren Mendez and Sophia Jeffe, both Youth Ambassadors, testified in front of the California Senate Human Services Committee about their experiences in the child welfare system and why a Kin-First Culture is so important. They showed courage and resilience as they discussed the need for improved oversight and structure within the system, as well as greater engagement with potential relatives. Not only was the impact of their experiences and wisdom felt in the moment, but may influence child welfare system improvement in the years to come.

## ***National Youth in Transition Database (NYTD) Workgroup***

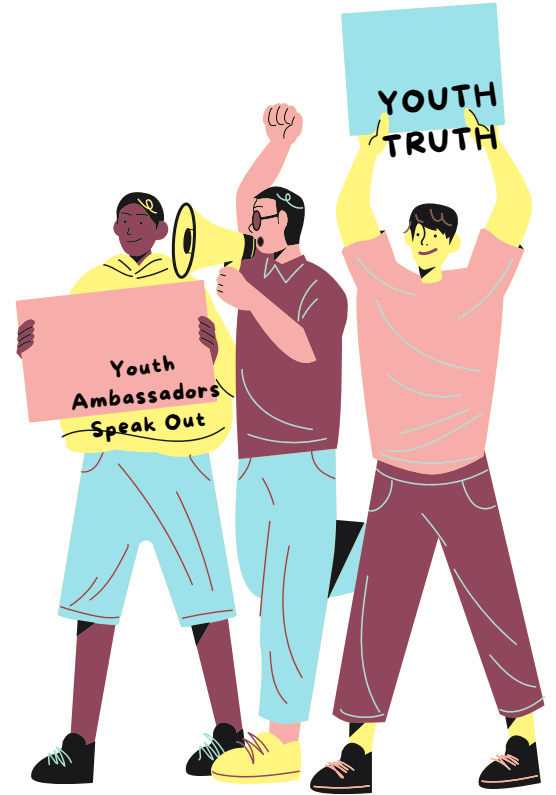
NYTD collects outcome data for transitional age youth through a federally created, mandated survey. In March, Joseph Mariscal joined the NYTD workgroup and provided his thoughts on improvements to the existing annual survey. The primary goal of this committee is to create a maximum of 10 more questions to better understand the needs of California's Transition Age Youth, to be determined by mid-July, 2024.

# County Partner Updates

Each YEP county has been matched with 2-3 Youth Ambassadors who are able to support county-level projects for approximately 8-10 hours per month, as counties discuss various ways to infuse youth voice and lived experience into their practices and policies. This portion of the newsletter highlights the innovative work done by Sonoma County to create system change by lifting up youth voices.

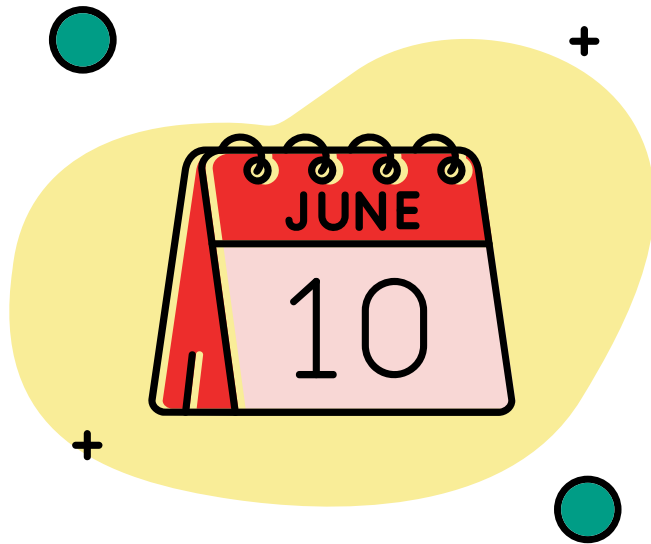
Sonoma County is using youth voice in a pivotal way by including Youth Ambassadors in their process to onboard a new STRTP provider. Youth Ambassadors Angel Burdick and Alex Crossman are part of the hiring process and requirements review, ensuring that youth voice is at the center of the clinical services for adolescents who will be residents of the facility.
